

Rules and Instructions for the xpedx Stores – E-com WIN1 Promo:

Complete Contest Rules

1. **Contest:** xpedx Stores, a division of International Paper Company (“xpedx”), is running a contest whereby contestants are eligible to win one (1) \$500 Visa Gift Card, one (1) 16GB Apple iPad 2 or one (1) Amazon.com Kindle.
2. **Entry:** There are two ways to enter the contest:
 - a. **Entry by Online Purchase:** You may enter the contest by completing a purchase transaction online at <https://shop.xpedxstores.com/>, entering “WIN1” in the coupon code field.
 - b. **Entry by Mail:** : You may enter the contest without making any purchases by sending a 3”x 5” card with the following legibly hand printed or written information:
 - Your name,
 - Your Company name (if applicable),
 - Your shipping address,
 - Your telephone number,
 - Your email address,in a postage paid envelope to: Advertising/WIN1, 3351 W. Addison Street, Chicago, IL 60618. One entry per envelope. Entries that do not include the required information will be disregarded without further notice. Entry must be received by the last day of the Contest Period to be eligible for the drawing.
3. **No Purchase Necessary.** NO PURCHASE IS NECESSARY TO ENTER THIS CONTEST. If you wish to enter without making a purchase, you may enter by following the instructions in Section 2.b. above.
4. **Contest Period.** Contest begins April 15, 2011 and ends May, 15 2011 (the “Contest Period”). All entries must be received by xpedx by 11:59 pm Central Standard Time on May, 15 2011.
5. **Drawing.** Winners will be selected by a random drawing on May 20, 2011. LIMIT ONE PRIZE PER PERSON. Winners will be notified by e-mail (either at the e-mail address on file with xpedx in the case of an entry by online purchase, or at the e-mail address listed in the written entry in the case of an entry by mail) within five (5) days after the drawing. To receive a winners’ list send a self-addressed stamped envelope by June 13, 2011 to: xpedx Stores, Advertising/WIN1, 3351 W. Addison Street, Chicago, IL 60618.
6. **Winner’s Agreement.** Winners will be required to sign and deliver to xpedx a "Winner's Agreement" within 14 days of receiving notification of award and the form. If signed Winner's Agreement is not received within prescribed period, xpedx will assume winner has relinquished the prize and an alternate winner will be selected.
7. **Prizes.** Prizes are one (1) \$500 Visa Gift Card; one (1) 16GB Apple iPad 2 tablet computer with Wi-Fi (black) and an approximate retail value \$499; and one (1) Amazon.com Kindle electronic reader with Wi-Fi and an approximate retail value \$139. xpedx reserves the right to substitute a similar item of equal or greater value if the designated prize is not available. Prizes must be accepted as awarded. Prizes are non-transferable. There is no prize or cash substitution. “Visa,” “Apple,” “iPad,” and “Kindle” are marks of their respective owners.
